This is to confirm that:

The Contributor understands that the CTODP must first request pre-approval from the Arizona Department of Revenue, (“ADOR”), of the Contributor’s proposed Contribution and that such Contribution may be subject to a pro-rata reduction based upon the total contributions approved by ADOR, which aggregate sum for all contributions may not exceed the statutory maximum. The Contributor further understands that in the event that ADOR approves the proposed Contribution, the Contributor must deliver its Contribution to the CTODP within ten (10) days after receiving notice from the CTODP that the proposed Contribution has been approved by the ADOR. The Contributor further understands that in the event that the CTODP does not receive the approved Contribution, or the reduced pro-rated amount, if applicable, within the aforementioned ten (10) day period, the Contribution will automatically lose its ADOR approval and will not be eligible for the tax credit provided by A.R.S. § 43-1183. Under the foregoing circumstances, the Contributor hereby agrees to deliver the approved Contribution, or the reduced pro-rated amount, if applicable, to the CTODP within ten (10) days after receiving notice from the CTODP of ADOR’s approval of its proposed Contribution.

If, at any time, a designated school does not have one or more students who are eligible to receive tuition assistance under the requirements of A.R.S. § 43-1183 so as to allow for the full use of the Contribution, the Contribution, or the unused portion thereof, will be re-directed first to provide tuition assistance to students at any other school(s) designated on this form, and if no other school is designated or eligible students are not available at any of the other designated schools, the Contribution, or unused portion thereof, will be deposited into CTODP's "General Scholarship Fund" and used for tuition assistance for CTC-qualified students at any of our Catholic schools.
